Dear 4-H Clothing Project Member,

We were glad to receive your entries for this year's 4-H Fashion Revue. Judging and the Public Fashion Revue will take place on **July 14th, 2022** at the Ellis Co. Fairgrounds. Enter through Schenk building doors.

This year you will select your times to visit with the judges through SignUp. There are 4 judges and 4 scheduling links. You can find them on the Ellis Co. 4-H Fair website. **Please try to select your times by July 6 so that we can finalize and post the schedule.**

Remember, if you have not yet turned in your script cards, please do so by July 11. You will also need to enter your exhibits (Constructed & Modeling) into the Fairentry.com system by 11:59 p.m. on July 11.

Please be dressed in your first outfit by 15 minutes before your scheduled time. If you have an early appointment, you may have time to come and go prior to the Fashion Revue. The public Fashion Revue will be held in the Unrein Family Building, beginning at 6:30 p.m.

There will be a Fashion Revue practice session at the end of each shift on stage in the Unrein Building for you to get the feel of the stage. ***Cloverbuds should plan to attend practice at 5:45 p.m. and then dress for the show.***

The script you submitted will be used for the Fashion Revue. We will double check it at the judging time. If you have things to change on it (like using different accessories than you originally submitted), that will be your chance to make the changes.

IMPORTANT - Fashion Revue Judging sheets are required for each outfit and are due at check in on July 14th. These forms will then be displayed at the Fair. The judging sheet must be fully completed with photos attached.

The schedules will be posted on the Ellis Co. 4-H page of the website. www.cottonwood.ksu.edu

There will be call-backs at the end of the public revue, so plan to stay until the end of the 4-H Fashion Revue, so you don't miss out on this important recognition.

There will also be Life Skills judging set up to participate in while you wait or after your shift is complete, from 2:00 – 5:00 p.m. Judging at this event and at the County Fair Life Skills judging will qualify those 9 & older for consideration for a Kansas State Fair judging team.


