**Stall Deposits** - \$5 per animal is needed for each animal. Submit stall deposit and photo/insurance checks separately—two checks required, *made payable to Ellis Co. 4-H Ag Livestock*.

**Photo & Frames** - The Ag Livestock Committee will again provide frames for pictures this year. \$9/animal includes two framed photos—one for the buyer, one to keep. Photo schedules vary by animal. **Fairgrounds Clean Up Night is Wednesday, July 9 –** RSVP to the Extension Office by **July 1**. Pizza will be provided by Commerce Bank—thank them for their support!

**Parking during clean up night** – The Fairboard asks that folks not park to the East and North of the livestock barn on clean up night, so that the area can be mowed.

Livestock Release - Each family is asked to check out with an Extension Agent before leaving to receive their stall deposit. Forfeited deposits will be used to support improvements in the respective barn.

# **HEAT CONTINGENCY PLAN**

**NEW THIS YEAR** - In the case of an excessive heat forecast during the Ellis County Fair, the Ellis County Fair Board will implement the livestock heat contingency plan for Beef, Sheep, Swine, Goats, Rabbits, and Poultry. **Implementation of the Heat Plan will be determined the week of the fair.** Please check the fair bulletin boards, the Ellis County Extension website <u>www.cottonwood.k-state.edu</u>, 4-H and Fair Facebook pages for information concerning the Heat Plan.

# **LIVESTOCK ANIMALS**

**Livestock Insurance** - The insurance available is \$7 per animal. Coverage starts when the animals leave the farm en route to the fair. Coverage ends when the animal is loaded onto the trailer at the end of the Fair. The company's limit of liability shall not exceed 25% over market value.

**Bedding Policy -** In order to avoid the drains from stopping up, most of the pigs will be stalled north of the wash pens. They will not be allowed to use any kind of bedding. (Rubber mats are acceptable). The sheep and any goats will be allowed bedding, but the pens will be dry. No water can be used to hose down pens, etc, just to fill livestock water pans.



**Health Requirements** - Please be aware of the **health requirement for swine and sheep.** The State of Kansas Animal Health Department **no** longer requires that swine be tested for pseudorabies and brucellosis.

Sheep will **not** have to have health papers stating they are free of sore mouth and club lamb fungus infection. However, a Veterinarian will check animals prior to you unloading them at the fairgrounds. If an animal is suspect, they will be asked not to unload. **Sheep and Goats** should have a scrapie tag / premise identification tag (provided by the livestock breeder).

**Drug Withdrawal / Age Verification Forms** - Each livestock exhibitor selling a *market animal* must sign a drug withdrawal form. As part of the food chain, it's your responsibility to ensure animal safety for consumers.

**Livestock Processing –** It is the responsibility of the 4-H family to work with the sale buyer to make appointments and transport livestock to the processor. Appointments fill quickly, so visit with local lockers NOW.

## **SMALL ANIMAL**

**Health Requirements** – All poultry exhibiting at the Ellis Co. Fair must originate from a hatchery or breeding flock that is classified U.S. Pullorum-Typhoid Clean under the National Poultry Improvement Plan (NPIP). Poultry shown at State Fair must be tested each year and found free of pullorum-typhoid diseases.

All poultry must have a negative Pullorum-Typhoid test prior to entry in the fair. We are working to have a county-wide testing date in the middle of June. Please be watching for more information for this. If you are unable to make this date, it is your responsibility to make other arrangements with a certified tester.

**Cats & kittens –** All will need a proof of vaccinations or vet check before entering at the fair. Please bring this paperwork with you for check in.

### HORSE

**4-H Horse Show** – As always, volunteers are needed to help run a safe & successful Horse show. Pictures will be on the morning of the show, Sunday July 13<sup>th</sup> at 8 am. If you are willing to help out, please contact the Extension Office.
