Unofficial Minutes 4-H Ag Livestock Committee November 18, 2019

The Ellis County A Livestock meeting was called to order on November 18, 2019 by Quentin Rupp.

There was no Small Animal or Horse report given.

Justin Scheck gave a Fairboard report of the damage the fairground buildings endured from the summer storm. He also suggested the idea of building an eighteen foot awning by the chicken barn with an estimate of \$14,000. He also said that we spend \$600-\$650 in tent rental for that area each year.

The election of officers for the 2019-2020 year was held. President is Quentin Rupp, Vice-President is Colton Vajnar, Secretary is Kaden Haas, Treasurer is Dalton Robben and the two adult advisors are Laycie Haas and Melissa Robben.

In old business, a motion was made by Lindsey Scheck to purchase 500 picture frames and 100 buyer ribbons for the upcoming fair. Colton Vajnar seconded the motion and the motion passed. Other old business included a motion from Colton Vajnar to charge \$9 for photos at the 2020 Ellis County Fair. The motion was seconded by Blaise Staab and passed. Wade Pfannenstiel was contacted about working on the manure spreader and said he will begin working on it after fall harvest.

In new business, the two goals that were set for the 2019-2020 year were planning a Vet Tour at KSU and hosting a Showmanship Clinic. The Livestock ID Procedures sheet was reviewed for changes. They added the statement that "scrapie tags should be in the ear of the animal at weigh-in time". Colton Vajnar made a motion to approve the changes and Blaise Staab seconded the motion. The motion passed. A motion was made by Kaden Haas to set the Market Beef Weigh-In Date and Time for February 1, 2020 from 9-11 a.m. Lindsey Scheck seconded the motion and the motion passed.

Blaise Staab made a motion to adjourn the meeting and Colton Vajnar seconded the motion. Meeting was adjourned.
